MEMBERS' CODE OF CONDUCT REGISTER OF MEMBERS' INTERESTS

Declaration of personal interests for inclusion in the public register of members' interests

The law, and the Council's Code of Conduct, require you to declare personal interests. Some personal interests have to be recorded by you in the statutory public register, within 28 days of the Authority's Code of Conduct being adopted or of your election (if later), or appointment to office (if later), and have to be updated by you within 28 days of any change. (There is an exemption from having to declare 'sensitive information', the Monitoring Officer can advise you about this).

Your declaration must include the interests of close family members and/or children.

A 'Related Party Transaction' is a transaction which a councillor, Clerk or their close personal associate via another entity (company, trust, etc) has with the council i.e. the provision of services or contractual arrangements.

1.6 Give the address or other description (sufficient to identify the location) of any land in which you have a beneficial interest* and which is in the area of this Council.
